

RESOLUTION NO. 2019 - 43

**A RESOLUTION APPROVING A MAJOR ADJUSTMENT TO THE CAMP SAFETY
EQUIPMENT PLANNED UNIT DEVELOPMENT**

WHEREAS, application (the "Application") was made by Mark Dierkers (the "Applicant") on behalf of Thomas H. Camp (the "Owner") for approval of a major adjustment to a planned unit development to allow two new one story additions to an existing 785 square foot storage building for the real property located at 8352 Blue Ash Road and 8354 Blue Ash Road, Sycamore Township, Hamilton County, Ohio, in Sycamore Township Zoning Case No. 2019-04MA; and

WHEREAS, the real property in Case No. 2019-04MA, consists of the real property located at 8352 Blue Ash Road and 8354 Blue Ash Road, Sycamore Township, Hamilton County, Ohio and is designated as Hamilton County Auditor's Parcel Numbers 600-0203-0522-00 and 600-0203-0523-00 (the "Real Property"); and

WHEREAS, the Real Property is located in an "EE"- Planned Retail District requiring an approval of any changes to an approved Plan; and

WHEREAS, on March 11, 2019, after proper notice having been given, the Sycamore Township Zoning Commission held a public hearing to consider the Application for the major adjustment to the plan on the Real Property; and

WHEREAS, on March 11, 2019, the Sycamore Township Zoning Commission recommended approval of the Application with conditions; and

WHEREAS, on April 4, 2019, after proper notice having been given, the Board of Township Trustees of Sycamore Township held a public hearing to consider the Application for the major adjustment to the plan for the Real Property;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The Application as set forth in the plans and specifications as presented to the Board of Township Trustees on April 4, 2019, is hereby approved.

SECTION 2. Except as amended herein, any use and improvements to the Real Property which is the subject of this Resolution shall be in complete compliance with previous approved applications for the Real Property.

SECTION 3.

No Zoning Certificate shall be issued by the Zoning Administrator until:

- A) a Zoning Compliance Plan in compliance with this Resolution has been received and approved by the Zoning Administrator if required;
- B) all documents submitted for zoning certificates are fully coordinated and consistent with the approved Zoning Compliance Plan if required;

No building permit for actual construction shall be issued by the Hamilton County Building Commissioner before a Zoning Certificate is received from the Zoning Administrator.

SECTION 4.

No Final Zoning Certificate shall be issued by the Zoning Administrator until the development complies with all requirements contained in this Resolution and the Zoning Compliance Plan if required.

SECTION 5.

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.


SECTION 6.

This Resolution shall take effect on the earliest date allowed by law.


