Failure to comply with Ohio Fire Codes on the **4th re-inspection** there is a re-inspection fee due in the amount of **\$200.00** and a notice to the building owner if different from the tenant and if no violations have been corrected.

Failure to comply with the Ohio Fire Codes on the **5th re-inspection** there is a re-inspection fee due in the amount of **\$500.00** and a second notice to the building owner if different from the tenant. This fee will continue until all violations have been resolved.
